2026 TERMS AND CONDITIONS

Your membership is governed by this agreement:

1. Memberships and payments can be suspended for a minimum 3 weeks for holidays or illness. This must be done in writing reception@westerfolds.com.au and pro rata rates will apply accordingly. A medical certificate is required for a suspension due to medical reasons.
2. Membership is only to be used by the person signing to be a Westerfolds Sport Centre Squash Member. All non member **guests will incur a fee of \$15, per booking**. This is payable on arrival. If playing outside of manned hours, honour system applies (to be paid on your next visit to the center).
3. Membership payments are via a fortnightly direct debit payment. It is the members responsibility to ensure they have adequate funds available. Should a payment fail to be processed a \$15.00 dishonour fee will be applied to your account.
4. Any changes to a member's payment details must be updated via the [client portal](#).
5. All memberships are a minimum 4 weeks in duration. Should you wish to cancel your membership, 4 weeks notice in writing is required.
6. If you choose to cancel your membership while participating in pennants, you will be charged the full Club Fees rate.
7. If you choose to cancel your membership while participating in Westerfolds Internal competitions, you will be required to pay the remaining weeks.
8. Memberships are ongoing unless an end date is specified by Member or Westerfolds Sports Centre.
9. It is a member's responsibility to ensure they are using courts in an appropriate manner and that they adhere to [Sport Integrity Australia](#) fair sport standards.
10. It is a member's responsibility to ensure they are healthy and able to play squash.
11. Westerfolds Sports Centre is not to be held liable for medical conditions, issues or injuries that occur at Westerfolds Sports Centre.
12. Westerfolds Sports Center reserves the right to amend these terms and conditions with 7 days written notice.
13. Westerfolds Sports Centre reserves the right to terminate this agreement at any time. The agreement termination will be notified immediately to the member, in writing (email).
14. Westerfolds Sports Centre is under 24 hour CCTV surveillance.

DIRECT DEBIT REQUEST SERVICE AGREEMENT

1. I hereby request and authorise Westerfolds Sports Center to debit my nominated bank account/credit card for the amount specified in the Direct Debit Request.
2. It is my responsibility to check with my financial institution whether direct debiting is available from my account. Direct debiting is not available on all accounts by all financial institutions.
3. If my direct debit is being taken using my bank account details and falls on a day which is not a business day, then Westerfolds Sports Center will direct my financial institution to debit my account on the next business day.
4. If I wish to change or stop this direct debit, I may do so by applying in writing, providing the terms of the Membership Agreement with Westerfolds Sports Center have been fulfilled.
5. I am responsible to inform Westerfolds Sports Center of any changes to the details I have provided on the Direct Debit Request form.
6. It is my responsibility to ensure cleared funds are available in my nominated bank account/credit card to meet the direct debit payment. If a debit is unsuccessful, I acknowledge that I will be responsible for payment of the debit plus an additional \$15 dishonour fee incurred by Westerfolds Sports Center, as well as any other fees charged by my financial institution.
7. I should check my account statement to verify that the amounts debited from my account are correct. All enquiries in relation to a dispute must be directed to Westerfolds Sports Center or my financial institution.
8. I understand that Westerfolds Sports Center will keep any information in the Direct Debit Request forms confidential. Westerfolds Sports Center will make reasonable efforts to keep my information secure, and to ensure that anyone who has access to it does not make any unauthorised transactions, modifications, reproductions, or disclosure of that information. Westerfolds Sports Center will only disclose my information to the extent specifically required by law or for the purposes of this agreement.
9. Westerfolds Sports Center may provide my details to a third-party debt collection agency to pursue collection of outstanding funds.
10. Westerfolds Sports Center may vary any details of this agreement or the Direct Debit Request at any time by giving me at least 14 days written notice.
11. Westerfolds Sports Center will communicate any matter relating to the Direct Debit Request via SMS, email or phone to the contact details I have provided.

Westerfolds Sports Centre 24/7 Squash Access Waiver & Agreement **24 HOUR ACCESS RELEASE OF LIABILITY & ASSUMPTION OF RISK**

As a 24-hour secure-access fitness facility, The Westerfolds Sports Centre (hereafter referred to as the “WSC” or “Centre”), has the following policies and procedures. Please read the information carefully. If you have any questions, please ask.

Compliance with rules:

I understand and agree that a WSC membership is a special membership based on trust, and is a privilege, which can be taken away for any violations to the rules. As a WSC member, I agree to abide by all membership rules, which are posted at the Centre as well as on the WSC website. These membership rules may be amended from time to time at the sole discretion of the WSC Management.

The following rules below apply to a WSC membership in relation to access during non-staffed hours:

All members will receive a code upon request that will give them access to the Centre during non-staffed hours. Access to the Centre during non-staffed hours will be via the side door in the car park on Parker Street.

1. First initial KEY CODE is complimentary when you register for a Westerfolds Squash membership.
2. Replacement codes will incur a \$20 fee.
3. KEY CODE sharing is strictly prohibited and will result in immediate loss of membership; key code sharing is viewed by management as stealing services.
4. To enter the building use the door located in the Cuddly Bear Car Park, use your unique code followed by “#”.
5. Only active account members will be allowed entry.
6. Do not bring or otherwise allow a person younger than 18 years of age to access the WSC without permission from management.
7. Pre-approved members under the age of 18 must be accompanied by an approved member parent until they reach the age of 18.
8. Advanced pre-approved members under the age of 18 may be approved to enter the Centre unaccompanied if authorized by WSC management.
9. Improper unauthorized use of the WSC may result in member suspension or cancellation. No one may use your KEY CODE for any reason, and you are required to report any situation that appears to be code sharing to WSC staff.
10. The WSC reserves the right to suspend or cancel these rights, privileges, and/or membership of any member whose actions are detrimental to the use, safety, and enjoyment of the WSC.

11. All non-staffed hours' access must be pre-booked via online portal or by contacting the Centre.
12. All members are welcome to bring guests to WSC during non-staffed hours. Please note that a \$15 fee applies for each guest. Under our honor system, this fee should be paid during your next visit to the center during staffed hours.
13. Any member who permits unauthorized access to the center for non-members not included in their party will incur a \$50 fine. This fee will be automatically added to your next direct debit. Additionally, the member's access will be automatically suspended. The reactivation of membership access will remain at the discretion of management.
14. Stop playing/exercising if you experience a potential injury and seek medical attention.
15. Members and guests alone in the WSC should call 000 in case of an emergency.
16. All outside doors must remain closed during all non-staffed hours.
17. No one under the influence of alcohol or drugs is permitted in the WSC at any time. No alcohol-involved fitness activities are permitted without permission from Management.
18. Notify management if any equipment is not working properly or if you notice any potentially dangerous conditions within the WSC.
19. Return all WSC equipment and supplies to their designated storage place after using the equipment and pick up any items or trash brought into the WSC or bathrooms.
20. The WSC is monitored 24/7 by surveillance cameras. Do not touch, move, or unplug any security cameras.
21. Turn off court lights in the WSC when you have finished your booking (switch located on the left hand side of each court).
22. Retail items on display are not for sale during non-staffed hours. All items can be purchased when the Centre is staffed. Any items taken from the retail display without management approval will be considered as stolen and will be dealt with accordingly.
23. Be sure to firmly push the door closed and check to make sure it's locked!
24. If you are last to leave WSC, members must re-enter their unique key code, followed by "*" . This will re-arm the Centre.
25. Failure to follow these established guidelines will result in the revocation of your 24/7 access. It is essential that these procedures are adhered to consistently.

No Supervision

I understand I am purchasing a membership at a 24/7 facility that allows access at any time.

I acknowledge that access is available at any time and that supervision or assistance is only provided during staffed hours, which may change at the discretion of WSC. I understand that during non-staffed hours, there may be no one available to respond to medical emergencies, and WSC is not obligated to provide assistance during these times.

Furthermore, I recognize that while surveillance cameras are in use, they are for recording purposes and are not monitored continuously. I am aware that help will not be available during non-staffed hours, though I note that a first aid station and AED defibrillator are located on the wall outside of Court 1.

Acknowledgement of Risk and Waiver of Liability

I voluntarily assume all risks of injury, accident, death, loss, cost or damage to my person or property arising from my use of the WSC. I agree to release and hold harmless the WSC, its affiliated corporations, owners, directors, employees, representatives, management, and all others from any and all liability.

Furthermore, I release the aforementioned parties from any responsibility or liability for injury or damage to myself, including those caused by negligent acts or omissions, or any incidents arising out of my participation in activities at the WSC during both staffed and non-staffed hours.

This contract represents the complete understanding between you and Westerfolds Sports Center. No representations, written or oral, other than those contained in this contract and the WSC's other waivers, are authorized or binding. Should any part of this agreement become unenforceable due to legal or other regulatory changes, the remaining provisions shall remain in full force.

Additionally, you agree to promptly notify the WSC of any changes to your address, phone number, email address or payment information.
